School Health Education Program - LymeTV completed the development of its interactive animated segment for tick-bite prevention education in grades K-6. A new website was developed exclusively for the program at www.tickjedi.com. Distribution of the program progressed throughout the rest of the year with signups from schools across multiple states and a broad increase in the reach of our educational curriculum.

Production of Documentary for Awareness and Prevention - LymeTV was able to conduct additional expert interviews in 2021 after a pause in filming due to the COVID-19 pandemic. An interview was conducted with Dr. Monica Embers from Tulane University, as well as shorter segments filmed with members of Bay Area Lyme Foundation's scientific advisory board.

Public Outreach Programs - LymeTV has partnerships with other public health organizations that serve the unhoused and underserved of our community who are at high risk for tick-borne diseases due to sleeping outside. These partnerships including shelters for the unhoused, substance abuse shelters, youth nonprofits, and more. We provide free tick repellent and permethrin-treated socks to our community partners who distribute the materials directly to our target populations. We collaborate with and provide health education for our other organizational partners.
