Production of Documentary for Awareness and Prevention - LymeTV focused on consolidating previously filmed footage and preparation for further editorial work on the film.

We provide free tick repellent to our community partners who distribute the materials directly to our target populations. We collaborate with and provide health education for our other organizational partners.
